Elections - Elections to Urban Local Bodies, 2011 – Reservation of seats for Schedule Castes and Women in 8 Municipalities – Notified.

ORDER:

In the Government Order first read above, reservation in the Wards of the Municipalities for the 2006 elections were notified.

2. As per rule 4 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Delimitation of Ward or Divisions and Reservation) Rules, 1996, the reservation made for Scheduled Castes and Scheduled Tribes and Women belonging to Scheduled Castes and Schedule Tribes and Women in General shall be in vogue for two full terms of the council, namely ten years and rotated thereafter at every ten years interval based on the next higher percentage of population of respective groups.

3. Recently, the territorial limits of the 8 Municipalities of Kancheepuram, Namakkal, Karur, Hosur, Villupuram, Pudukottai, Nagercoil and Tirupathur have been expanded by merging certain local bodies with them.

4. By the orders issued in the Government Order second read above, the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Delimitation of Wards or Divisions and Reservation) Rules, 1996, have been amended to provide that, where there is any alteration in the territorial area of a Town Panchayat, Third Grade Municipality, Municipality or Municipal Corporation, as the case may be, before completion of two full terms of the municipal council of the respective urban local body, the reservation of seats prescribed therein, shall be made afresh for the next ordinary election to the municipal council of such urban local body.

5. The Commissioner of Municipal Administration in his letter third read above, has stated that based on the provisions of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Delimitation of Wards or Divisions and Reservation) Rules, 1996, and the amendments referred to, in para-4 above, has sent proposal for reservation in the Wards of the 8 Municipalities of Kancheepuram, Namakkal, Karur, Hosur, Villupuram, Pudukottai, Nagercoil and Tirupathur and requested necessary orders of the Government on the proposal.

6. The Government after careful examination of the above proposal of the Commissioner of Municipal Administration have decided to accept the same and ordered accordingly.

7. The appended Notification will be published in the Tamil Nadu Government Gazette Extra-ordinary, dated the 15th September, 2011.


