Order:

In the reference letter cited, the Director of Municipal Administration has informed to establish an Emergency Response sanitation unit (ERSU) for each Municipality regarding the Elimination of Hazardous and management of sewers and septic tanks with the following activities.

1. Operationalizing a dedicated sanitation emergency helpline number 14420 in all Municipal Corporation and districts.
2. Framing a time – bound action plan for fulfillment of manpower and Mechanization requirements including training and welfare measures in ULBs / clusters.
3. Thrust on mechanized cleaning of sewers and septic tanks, to minimize necessity of human entry.
4. Availability of proper protective gears and equipments also manual entry is unavoidable.
5. Creation of conducive eco-system through, trained workforce, large scale citizen outreach, 24x7 helpline, enforcement mechanisms.
