ORDER:

In the Government Order first read above, orders have been issued fixing the total number of Councillors to be elected to the councils of the Municipalities.

2. In the Tamil Nadu Ordinance fourth read above, the erstwhile Kumbakonam Municipality has been constituted as Kumbakonam City Municipal Corporation with effect on and from 20.12.2021.

3. As per section 5 (1) of the Kumbakonam City Municipal Corporation Ordinance, 2021, the Council shall consists of such number of Councillors as may be fixed by the Government, by notification, from time to time. However, the total number of Councillors of the Council should not exceed 72 (seventy two), at any time.

4. Based on this, in the letter fifth read above, the Government have requested the Tamil Nadu Delimitation Commission to fix the

strength of the Council of the Kumbakonam City Municipal Corporations as per section 4(1)(a) of the Tamil Nadu Delimitation Commission Act, 2017 (Tamil Nadu Act 23 of 2017).

5. In the letter sixth read above, the Member-Secretary, Tamil Nadu Delimitation Commission, has sent the following recommendation of the Commission regarding fixation of the strength of the Council of the Kumbakonam City Municipal Corporation, to the Government:—
