WHEREAS, the Delimitation Commission constituted under the Tamil Nadu Delimitation Commission Act, 2017 (Tamil Nadu Act 23 of 2017), submitted its recommendations for Delimitation of territorial Wards of Nagercoil City Municipal Corporation as required under section 4(1) of the Tamil Nadu Delimitation Commission Act, 2017 (Tamil Nadu Act 23 of 2017) and the same has been notified in the District Gazette, Extraordinary, dated the 31<sup>th</sup> December 2021.

AND WHEREAS, the Delimitation Commission has now submitted its recommendations for reservation of seats for the persons belonging to the Scheduled Castes and Scheduled Tribes, Women (General) in the territorial Wards of Nagercoil City Municipal Corporation to the Government, as required under section 4(1)(f) of the said Tamil Nadu Act 43 of 2017 and the same have been accepted by the Government.

NOW, THEREFORE, in supersession of the earlier Notification No:4 issued with ROC.No:1300/2019/A1, in the Kanniyakumari District Gazette, Extraordinary, dated the 4<sup>th</sup> June 2019 and in exercise of the powers conferred under sub-sections (4), (5) and (6) of section 5 of the Nagercoil Cith Municipal Corporation Act, 2019 (Tamil Nadu Act 11 of 2019) and the powers delegated to the Commissioner, Corporation of Nagercoil in G.O. (MS.) No:41, Municipal Administration and Water Supply Department, dated the 28<sup>th</sup> February 2019, published in Municipal Administration and Water Supply Department Notification No: II(2)/MAWS/205(h-4)/2021 at page 2 in part II-Section 2 of the Tamil Nadu Government Gazette, Extraordinary, dated the 1<sup>st</sup> March 2019 and based on the recommendation of Delimitation Commission and as accepted by the Government, the Commissioner, Corporation of Nagercoil hereby reserves the following divisions for the persons belonging to the Scheduled Castes and Scheduled Tribes and, Women belonging to the Scheduled Castes, Scheduled Tribes and Women (General) in the Nagercoil City Municipal Corporation, as specified in the Schedule below:-
