#### ORDER:

In the Government order read above, the Government have proposed to include the entire area comprised in the Thiruthangal Municipality within the limits of the Sivakasi Special Grade Municipality.

2. Further, in the Notification appended to the said Government Order, the Government have declared their intention to include the above said area within the limit of Sivakasi Special Grade Municipality and published a Notification in the Tamil Nadu Government Gazette, Extraordinary, dated 31.12.2020, inviting objection within a period of six weeks from the said date, which expired on 10.02.2021. During the above period of six weeks, objections against the said inclusion have been received from some Welfare Associations and the same have been examined by the Government.

3. After careful examination, the Government have decided to include the entire area comprised in Thiruthangal Municipality within the limits of Sivakasi Special Grade Municipality and to issue orders . accordingly. Based on the above inclusion, Wards will be divided for the next ordinary election.

4. The appended Notification will be published in the Tamil Nadu Government Gazette, Extraordinary, dated the 17.02.2021.
