**TAMBARAM CITY MUNICIPAL CORPORATION
NOTIFICATION**

(Roc.No.2419/2021/F1, dated 10.01.2022)

WHEREAS the Delimitation Commission constituted under the Tamil Nadu Delimitation Commission Act, 2017 (Tamil Nadu Act 23 of 2017), submitted its recommendations for Delimitation of territorial Wards of Tambaram City Municipal Corporation as required under section 4(1) of the Tamil Nadu Delimitation Commission Act, 2017 (Tamil Nadu Act 23 of 2017) and the same has been notified in the District Gazette, Extraordinary, dated the 31st December 2021;

AND WHEREAS, the Delimitation Commission has now submitted its recommendations for reservation of seats for the persons belonging to Scheduled Castes and Scheduled Tribes, Women belonging Scheduled Castes and Scheduled Tribes and Women (General) in the territorial Wards of Tambaram City Municipal Corporation to the Government, as required under section 4(1)(f) of the said Tamil Nadu Act 43 of 2017 and the same have been accepted by the Government;

NOW, THEREFORE, in exercise of the powers conferred under sub-sections (4), (5) and (6) of section 5 of the Tambaram City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 5 of 2021) and the powers delegated to the Commissioner, Corporation of Tambaram in G.O. (Ms.) No.100, Municipal Administration and Water Supply (Election) Department, dated the 12th November 2021, published in Municipal Administration and Water Supply Department Notification No. II/(2)/MAWS/789(b-5)/2021 at page 2 in Part II -Section 2 of the Tamil Nadu Government Gazette, Extraordinary, dated the 12th November 2021 and based on the recommendation of Delimitation Commission and as accepted by the Government, the Commissioner, Corporation of Tambaram hereby reserves the following divisions for the persons belonging to the Scheduled Castes and Scheduled Tribes, Women belonging to the Scheduled Castes and Scheduled Tribes and Women (General) in the Tambaram City Municipal Corporation, as specified in the Schedule below:—
