DRAINAGE BYLAW-AMENDMENTS

1. For the para No. 67 of the Udhagamandalam Municipality Drainage bylaw, the following shall be substituted, namely:-

"Any person who intends to avail the UGD connection for closets, sanitary fitting and sewerage connection for House / Hotel & lodging house / Business premises / Godowns / Business Complex / Institutions, Shall pay the monthly rates (service charges) at the rates prescribed below to the Udhagamandalam Municipality".

2. For the para No. 68 of Udhagamandalam Municipality Drainage bylaw, the following shall be substituted, namely:-

"Any person who intends to continue the service of the existing Municipal Under ground Drainage connection and also who intends to provide new under ground Drainage connection, for the following types of building shall be required to pay an initial amount to this Municipality as detailed below. :
