### ORDER:-

In the Government Order read above, Government have sanctioned a sum of **Rs.292,43,60,000**/- (Rupees Two Hundred and Ninety Two Crore and Forty Three Lakh and Sixty Thousand only) as the 2nd installment of General Basic Grant for the year 2018-19 under the award of 14<sup>th</sup> Central Finance Commission

The distribution formula as recommended in the Fifth State Finance Commission, Tamilnadu have been adopted for CFC grant as indicated below.

The Government have authorized the Commissioner of Municipal Administration to draw and disburse the above grants to the Municipal Corporations.

The Government had also directed to work out the sum eligible @ 10% payable to Chennai Metropolitan Water Supply and Sewerage Board from out of the Chennai Corporation's total share of  $14^{th}$  Central Finance Commission devolution.

Hence, sanction is hereby accorded for the release of Basic Grants Rs.292,43,60,000 (Rupees Two hundred and ninety two crore and forty three lakh sixty thousand only) as 2nd installment for the fourth financial year 2018-19 to the all Municipal Corporations, as per the **Annexure-I**.

All the Corporation Commissioners are instructed to utilize the Basic grants now distributed in the following order of priority:-

- 1] Payment of electricity charges of the Urban Local Bodies due to TANGEDCO.
- 2] Payment of water charges to the Tamil Nadu Water Supply and Drainage Board.
- 3] B.S.N.L. Charges towards E-Governance activities.
- Payment of Urban Local Body contribution for ongoing Water Supply and Under Ground Sewerage Schemes implemented by the Tamil Nadu Water Supply and Drainage Board (TWAD Board).
- Payment of Urban Local Body contribution for implementation of Solid Waste Management projects and payments to the outsourced agencies by the Municipal Corporations towards the Solid Waste Management activities.
- Separate account shall be maintained for CFC Grant allotment.

  Corporation Commissioners shall be able to furnish details of expenditure out of CFC devolution fund at anytime as called for by the Government.
