## ORDER:

As per Fifth State Finance Commission's recommendation the following criteria and weightages is adopted for sharing of SFC devolutions to Urban Local Bodies.

a) Population as per 2011 census : 65%
b) Area : 15%
c) Per capita Consumption Expenditure Distance : 10%
d) Proportion of Slum Population : 10%
Total : 100%

Government in the G.O. 2<sup>nd</sup> cited have accorded sanction for the release of Rs.112,03,95,000/- (Rupees One hundred tweleve crore three lakh and ninety five thousand only) as Devolution of 5<sup>th</sup> SFC to the CORPORATIONS for the month of September 2019.

In respect of Chennai, Coimbatore and Salem Corporations devolution for the month of September 2019 has not been taken into account since Ways and Means Advance amount recovery request for those Three Corporations to Government has not yet been finalized. After direction from Government, SFC Devolution will be worked out separately for those Three Corporations.
