- 2. In Government Order second read above, orders were issued for release of devolution grant to Municipal Corporations and Municipalities for the period from April 2018 to January 2019. Further it was ordered that the recovery of Ways and Means Advance sanctioned to the Greater Chennai Corporation, Coimbatore and Salem Corporations shall commence from the year 2019-2020.
- **3.** In Government Order third read above, orders were issued for release of devolution grant to Municipal Corporations and Municipalities for the period from April 2019 to January 2020 and the Commissioner of Municipal Administration was directed to recover the 1st installment of Interest Free Ways and Means Advance from the Greater Chennai Corporation, Coimbatore and Salem Corporations from their devolution grant for the year 2019-2020 are as detailed below:-

Therefore, taking into consideration of the financial positions of the above Urban Local Bodies, they have requested to defer the recovery of Interest free ways and means advance from the State Finance Commission devolution grant for the year 2019-2020.
- **5.** The Government after careful examination of the request of the Commissioner of Municipal Administration and the Commissioner, Greater Chennai Corporation and impact of G.O(Ms) No.150, Municipal Administration and Water Supply (MA4) Department, dated 19.11.2019 with-holding increase in property tax till the receipt of report of Expert Committee constituted have decided to accord permission to

Commissioner of Municipal Administration to defer the recovery of Interest Free Ways & Means advance sanctioned to the Greater Chennai Corporation, Coimbatore and Salem Corporations from their State Finance Commission Devolution Grant for first 2 quarters for the year 2019-2020 and orders accordingly.
