#### **ORDER:**

The Government, based on the recommendations of the Fifth State Finance Commission, vide the Government Order first read above, constituted Empowered Committee called 'Capital Grant and Operational and Maintenance Gap Filling Fund Committee' for approving projects / schemes for Urban Local Bodies and quidelines for utilisation of the funds.

2. The Commissioner of Municipal Administration in his letter second read above, has informed that the Empowered Committee for Capital Grant Fund and Operational and Maintenance Gap Filling Fund vide Circulation agenda dated 09.12.2019, approved the following project for Gudalur Municipality in Nilgiris District as below:-

Municipality for the Improvements and expansion of the existing Gudalur Bus Stand as per the provision made in B.E 2019-2020 and as approved by Empowered Committee in its circulation agenda dated 09.12.2019.

- **4.** The Government after careful examination of the proposal of the Commissioner of Municipal Administration have decided to accept the same and accord sanction to release Rs.1,00,00,000/- (Rupees One crore only) under Capital Grant Fund to Gudalur Municipality for the Improvements and expansion of the existing Gudalur Bus Stand, as per the provision made in B.E 2019-2020 and as approved by Empowered Committee in its circulation agenda dated 09.12.2019. The amount sanctioned above shall be spent strictly as per the guidelines issued in Government Order first read above.
- **5.** The amount sanctioned in para 4 above, shall be debited to the following head of account:
