ORDER:

The 14th Finance Commission has submitted its report and the recommendations of the Commission have been accepted by the Covernment of India and communicated to the State Governments. The award period of 14th Finance Commission is for the period from the year 2015-2016 to 2019-2020.

- 2. The 14th Finance Commission in its report as regards to General Basic Grant to Local Bodies inter-alia has recommended that the Basic grant for Urban Local Bodies will be divided into tier wise shares and distributed across each tier, namely the Municipal Corporations, the Municipalities (the tier II Urban Local Bodies) and the Nagar Panchayats (the tier III Local Bodies) using the formula given by the respective State Finance Commissions. The State Governments should apply the distribution formula of the most recent State Finance Commission, whose recommendations have been accepted. (Para-9.72)
- **3**. The 5th State Finance Commission among others at Para 10.74 has recommended that the vertical sharing ratio between the three tiers

of ULBs shall be arrived at as 40:29:31 for Municipal Corporations, Municipalities and Town Panchayats respectively.

- **4.** The Government of India, in its release order third read above, has sanctioned and released a sum of Rs.987.85 crore as second installment of General Basic Grant for the year 2019-2020 to Urban Local Bodies under the award of 14th Finance Commission.
- **5.** Accordingly, the Government accord sanction and release a sum of **Rs.987,85,00,000/-** (Rupees Nine Hundred and Eighty Seven Crore and Eighty Five Lakh only) as the second installment of General Basic Grant for the year 2019-2020 under the award of 14th Central Finance Commission to the Municipal Corporations, Municipalities and Town Panchayats as detailed below:

The grant released shall be utilized strictly in accordance with the guidelines issued by the Government of India.

- **6.** The amount sanctioned at para 5 above shall be debited under the following heads of account:
 - a. Municipal Corporations Rs.395,14,00,000/- (Rupees Three Hundred and Ninety Five Crore and Fourteen Lakh Only) 3604-00. Compensation and Assignments to Local Bodies and Panchayat Raj Institutions 191. Assistance to Municipal Corporations Central Sector Schemes SA. Basic Grants to Municipal Corporations as per the recommendations of 14th Finance Commission Controlled by Commissioner of Municipal Administration 309. Grants in aid-01 Grants for Current Expenditure. (DPC 3604 00 191 SA 30901) IFHRMS DPC (Old DPC 3604-00-191-SA-0914)

- 7. The Commissioner of Municipal Administration and Director of Town Panchayats are authorized to draw the amount sanctioned in para 5 above. The Commissioner of Municipal Administration is authorized to draw the amount as mentioned at paras 6 (a) and 6 (b) above and disburse the same to the Corporations and Municipalities respectively. The Director of Town Panchayats is authorized to draw the amount sanctioned in para 6 (c) above and disburse the same to the Town Panchayats.
- **8.** In the Government Order second read above, the Government have ordered that, 10% of the grant pertaining to the Chennai Corporation's share under the 14th Central Finance Commission award shall be allocated to Chennai Metropolitan Water Supply and Sewerage Board.
- **9**. The Commissioner of Municipal Administration is directed to work out the sum eligible to Chennai Metropolitan Water Supply and Sewerage Board from the Chennai Corporation's share of 14th Finance Commission grant in strict accordance with the above orders and credit the same to the Chennai Metropolitan Water Supply and Sewerage Board, as per the due procedure. The Commissioner of Municipal Administration and Director of Town Panchayats are also directed that the priority should be

accorded to meeting salary costs, especially of front line sanitary staff, payment of pending utility bills of Tamil Nadu Generation and Distribution Corporation, Tamil Nadu Water Supply and Drainage Board and other water supply and sanitation service providing entities. The Commissioner of Municipal Administration and Director of Town Panchayats are further directed that no new capital works, except those directly related to COVID 19 response shall be sanctioned or taken up.

- **10.** The Commissioner of Municipal Administration and the Director of Town Panchayats are requested to furnish necessary Utilization Certificate towards the Utilization of funds sanctioned at para 5 above in the prescribed format for forwarding the same to the Government of India, immediately.
- 11. Necessary additional funds will be provided in RE / FMA 2020-21 pending provision of such funds, the Commissioner of Municipal Administration and the Director of Town Panchayats are authorized to draw and disburse the amount. The expenditure shall be brought to the notice of Legislative by specific inclusion in Supplementary Estimates 2020-21. The Commissioner of Municipal Administration and Director of Town Panchayats are requested to send necessary proposal for inclusion of this expenditure in Revised Estimates 2020-21 and also send necessary explanatory note for inclusion of this expenditure in the next Supplementary Estimate 2020-21 at appropriate time.
