ORDER:

Based on the Fifth State Finance Commission recommendation vide the Government Order first read above, it has been ordered that the Devolution Grant for the Urban Local Bodies shall be released in 10 monthly instalments (from April to January) as per the existing procedure based on Budget Estimate provisions and the balance based on Revised Estimate provisions for State Own Tax Revenue (SOTR).

2) In the Government Order second read above, the Government have adopted a methodology that the provision made in the Budget Estimate 2020-2021 under the State Finance Grant, the 5% of amount to be devolved each and every month (from the month of April 2020 to January 2021) and the sanction for the balance amount would be accorded in 4 instalments from February to March 2020-2021. Accordingly, the Government have sanctioned for the release of Devolution Fund of the Fifth State Finance Commission to the Municipal Corporations and Municipalities for the months of April, May, June and July 2020.

3) In the letter fourth read above, the Commissioner of Municipal Administration has requested orders of the Government to release Devolution Fund as per the recommendation of the Fifth State Finance Commission to the Municipal Corporations and Municipalities for the month of August, 2020 and he has also requested to authorize him to draw and disburse the amount to Urban Local Bodies.
