ORDER:

The Government ordered in the G.O 1st read above that the Surcharge on Stamp Duty collected in respect of Municipal Corporations, Municipalities and Town Panchayats, was placed at the disposal of the Commissioner of Municipal Administration/ Director Town Panchayats instead of the Inspector General of Registration and the District Collectors.

2) Accordingly in the reference 2nd read above, report was received from the Inspector General of Registration for the quarter ending June 2017 on Surcharge on Stamp Duty collected during the quarter. Based on the report necessary proposal has been sent to Government in the reference 3rd read above. Considering the proposal of the Commissioner of Municipal Administration, Government have issued Order vide G.O 4th read above.

3) The Government in their order 4th read above has sanctioned funds towards the release of Surcharge on Stamp Duty as well as TURIF for a sum of Rs.75,56,33,088/- respectively by relaxing the Quarterly Control of Appropriation System for which orders issued in G.O. (Ms) No.78, Finance (BG.I) Department, dated.30.03.2017 and the Commissioner of Municipal Administration is authorized to draw and disburse the above sanctioned amount to the concerned ULBs and TNUFISL, Chennai-28.

4) In view of the above, Sanction is hereby accorded for the drawal of Rs.75,56,33,088/- (Rupees Seventy Five Crore Fifty Six Lakh Thirty Three Thousand Eighty Eight only) towards the disbursement of Surcharge on Stamp Duty to ULBs for quarter ending June 2017 and for the drawal of Rs.75,56,33,088/- (Rupees Seventy Five Crore Fifty Six Lakh Thirty Three Thousand Eighty Eight only) is also sanctioned towards the contribution to Tamil Nadu Urban Road Infrastructure Fund (TURIF).

The above expenditure shall be debited in the Head of Account:-
