I am to invite your attention to the references cited.


2. In the reference seventh cited, orders were issued that the category of employees drawing higher pay scales / pension by virtue of court orders till date were permitted to migrate to revised pay structure based on the orders issued in the reference fourth cited or continue to draw the pay being drawn by them presently based on the interim orders of the Hon'ble Court, Madras whichever is financially advantageous to them subject to the outcome of the final verdict in the court cases.

3. In reference ninth cited, the Hon'ble Supreme Court of India has inter-alia directed that affected categories who were drawing higher pay shall not be permitted to migrate to 7th Central Pay Commission Scales on the basis of the higher scales till a final decision is taken upon constituting Pay Grievance Redressal Committee.

4. In the reference tenth cited, Pay Grievance Redressal Committee has been constituted under the Chairmanship of Hon'ble Thiru. Justice D.Murugesan, formerly Chief Justice, High Court of Delhi.

5. I am therefore, to clarify that the employees who were drawing higher pay scales by virtue of court orders shall not be permitted to migrate to the Tamil Nadu Revised Pay Structure 2017, on the basis of higher scale, on or after 05.12.2019 till a decision is taken by Government on the report of the Pay Grievance Redressal Committee constituted in reference tenth cited. I am to request you to follow the above instruction scrupulously failing which responsibility will be fixed on the pay fixing authorities.
