ORDER:

In the letter second read above, the Commissioner of Municipal Administration has sent a proposal to Government to issue necessary Administrative Sanction for the Implementation of Water Supply Improvement Scheme to Madurai Corporation from the Lower camp of Mullai Periyar Dam at an estimated cost of Rs.1020.00 Crore under Atal Mission For Rejuvenation and Urban Transformation /Asian Development Bank for installation with the financial Pattern as sanctioned by Tamil Nadu Urban Finance and Infra Structure Development Corporation.

2. The Commissioner of Municipal Administration has also stated that, as per the guidelines of Government of India, Service Level Implementation Plan (SLIP) for the 26 Urban Local Bodies have been prepared and based on that, State Annual Action Plan (SAAP) 2017-20 has been prepared and got approved from the Government of India

for

Rs.4153.62 Crore. The Detailed Project Report for providing Water Supply Improvement Scheme to Madurai Corporation with source from Lower camp of Periyar Dam has been prepared by the Urban Local Bodies through Consultants appointed by them. Both the State Level Technical Committee (SLTC) and State Level High Powered Steering Committee (SLHPSC) approved the proposal. The Commissioner, Madurai Corporation has stated that, the Council passed the Resolution vide No.178 dated 14.07.2017 for taking up the implementation of the scheme with financial assistance from Government of India, Government of Tamil Nadu and also makes necessary arrangements for balance fund tie up from Asian Development Bank (ADB) for which, TNUIFSL is taking necessary action. The Scheme will be done by the respective ULBs by availing technical assistance of Project Management Consultancy (PMC) appointed by the TNUIFSL from PDGF maintained by them.

3. In the letter third read above, the Chairman & Managing Director, Tamil Nadu Urban Finance and Infra Structure Development Corporation has issued the Sanction letter for the approval of Implementation of Dedicated Water Supply Scheme to Madurai Corporation from Mullai Periyar River as source at a total estimated cost of Rs.1020.00 Crore under AMRUT/ADB with the following funding pattern:-


