ORDER :

In the G.O 2nd read above Government have accorded sanction for release of a sum of **Rs.2,38,74,000/-** to one Municipal Corporation (Thoothukudi) and **Rs.11,88,95,000/-** to Twenty five Municipalities as Incentive Fund, being the Matching share of property tax collection in excess of 10% growth rate for the year 2018-2019 subject to the conditions that the Urban Local Bodies shall conduct special drives frequently to access the properties under their purview with an object of detecting under assessed or unassessed properties, which would intensify the property tax collection and enable the Urban Local Bodies to receive the Incentive for the ensuing years.

Accordingly a sum of **Rs. 2,38,74,000/-** being the incentive fund towards one Municipal Corporation (Thoothukudi) and sum of **Rs.11,88,95,000/-** being the Incentive Fund towards Twenty five Municipalities is released as detailed below:-
