**ORDER:-**

In the Government Order read above, Government have sanctioned a sum of **Rs.116,50,00,000/- (Rupees One hundred and Sixteen crore and fifty lakh only)** as the second installment of 15<sup>th</sup> Central Finance Commission Grant for the year 2020-2021 for improving ambient air quality to **Million Plus Cities** (i.e) Greater Chennai Corporation, Madurai and Tiruchirappalli Municipal Corporations as detailed below:-


