ORDER:

In the letter first read above, the Government of India had released a sum of Rs.295.25 crore as first instalment of Non-Million Cities Basic Grant (untied) for the year 2020-2021 to Urban Local Bodies of the State under the award of 15th Central Finance Commission.

- 2. In the Government Order second read above, orders were issued for releasing a sum of Rs.295.25 crore as first instalment of Basic Grant (untied) to Non-Million Plus Cities of the State and authorized the Commissioner of Municipal Administration and Director of Town Panchayats to draw and disburse the grant to the Urban Local Bodies and Cantonment Boards.
- **3**. The Commissioner of Municipal Administration and the Director of Town Panchayats in their letters fourth and fifth read above, have stated that in Government Order (D) No.213, Municipal Administration and Water Supply (FC) Department, dated 23.06.2020, orders have been released by the Government beyond the time limit of 10 working days as prescribed by the Government of India. Hence, it was requested to release the interest amount of Rs.1,26,07,175/- at the rate of 7.32% for 21 days for delayed transfer of first instalment of Basic Grant (untied) to Non-Million Plus Cities for the year

2020-2021 under 15th Central Finance Commission amounting for as detailed

- 4. The Government after careful examination of the proposal of the Commissioner of Municipal Administration and the Director of Town Panchayats has decided to accord sanction a sum of Rs.1,26,07,175/-(Rupees one crore twenty six lakh seven thousand one hundred and seventy five only) as penal interest for 21 days for delayed transfer of first instalment of Basic Grant (untied) to Non-Million Plus Cities under 15th Central Finance

- 6. The Commissioner of Municipal Administration and the Director of Town Panchayats are authorized to draw the amount sanctioned in para 4 above. The Commissioner of Municipal Administration is authorized to draw the amount as mentioned at paras 5(a), 5(b) and 5(c) above and disburse the same to the Cantonments Boards, Municipal Corporations and Municipalities respectively. The Director of Town Panchayats is authorized to draw the amount sanctioned in para 5(d) above and disburse the same to the Town Panchayats.
- 7. The Commissioner of Municipal Administration and the Director of Town Panchayats are requested to utilize the above sanctioned amount for settlement of electricity charges and water charges.
