- 2. The purpose of this assignment is for Consultancy services for "Establishment of Programme Implementation Units (PIU) to provide handholding support to Mission Director, Swachh Bharat Mission Urban 2.0 (SBM 2.0), Tamil Nadu"as mentioned in the Terms of Reference (ToR).
- 2.1 Client means Mission Director, Swachh Bharat Mission Urban 2.0 (SBM 2.0), Tamil Nadu.
- 3. A firm will be selected under Quality and Cost Base Selection (QCBS) procedures described in this RFP and in accordance with the procurement guidelines of the TAMIL NADU TRANSPARENCY IN TENDERS ACT, 1998 and RULES 2000 as amended from time to time.

- 6. <u>The Submission of Proposals</u>:
- 6.1 The proposals addressed to Mission Director, SBM (U), Tamil Nadu shall be submitted in three parts, viz., Pre-qualification, Technical and financial and should follow the form given in the "Supplementary Information for Firms."
- 6.2. The "Pre-qualification", "Technical" and "Financial" proposals must be submitted in three separate sealed envelopes (with respective marking in bold letters) following the formats/schedules given in the Pre-qualification for firms (Annexure-2), supplementary information for firms (Annexure-3). The first envelope marked "Pre-qualification criteria" in one separate cover, viz., Cover-1 must be sealed with sealing wax and initialled twice across the seal. This cover should contain the Earnest Money Deposit (EMD) of **Rs. 1,63,200/-** in the form of Demand Draft to be taken in the name of "Mission Director SBM(U), Tamil Nadu,"Chennai 600 028. The EMD of unsuccessful firms will be returned within 45 days of the date of completion of selection / tender process. This cover should contain the Processing fee of **Rs. 5000/-(Non refundable)** in the form of Demand Draft to be taken in the name of "Mission Director SBM(U), Tamil Nadu, "Chennai 600 028.
- 6.3 EMD will be refunded for successful bidder after the successful completion of mission period and subject to extensions without any financial implications.
- 6.4 The second envelope, viz., Cover-2 marked "Technical proposal for the captioned project" must also be sealed and initialled twice across the seal and should contain information required in Annexure 3 viz., supplementary information for firms.
- 6.5 The first and second envelopes <u>should not contain any cost information whatsoever</u>. The third envelope viz., Cover-3 marked 'Financial Proposal for the captioned project'' must also be sealed and initialled twice across the seal and should contain the detailed price offer for the firms services.

You will provide detailed breakdown of costs and fees in the format prescribed in Form 6:

The sealed envelopes Cover 1, Cover 2 and Cover3 should again be placed in a separate sealed in one cover, which shall be clearly marked with the name of the assignment and received in the office of the Directorate of Municipal Administration ,No. 75, Santhorme High Road,MRC Nagar, Raja Annamalaipuram, Chennai – 600 028, up to 03.30 PMon20.05.2022.

If the cover of proposals is not marked with the name of the assignment indicating the bid submission date and time, the cover will not be opened and returned to the firm unopened treating as "Not Qualified".

### 6.6 **Opening of proposal.**

The proposals (first envelope (cover 1) containing pre-qualification criteria only) will be opened by the Mission Director or his authorized representative in its office at **04.00 PM** on **20.05.2022.** It may please be noted that the second envelope containing the technical proposal will not be opened until pre-qualification criteria is evaluated, and detailed price offer will not be opened until technical evaluation has been completed and the result approved and notified to all firms.

### 7. **Evaluation**

- 7.1 A three stage procedure will be adopted in evaluating the proposals:
  - i. A pre-qualification of firms will be verified, which will be carried out prior to opening of technical proposal (as per Annexure 2)
  - ii. A technical evaluation of the pre-qualified firms will be carried out based on the project Experience and CVs of the Key Personnel proposed in appropriate markingsystem
  - iii. A Financial évaluation of the technically qualified firms

### 7.2 **Pre-qualification** – (Cover 1)

Firms who have the following qualifications may submit the proposal along with necessary proof (Assignment along with client certificate duly attested by a Notary Public will only be considered for evaluation)—

- (i) The Consultant / Outsourcing agency/ Outsourcing Agency shall be an entity incorporated under the Indian Companies Act 1956/2013/ Tamil Nadu Societies registration act 1975 and should submit registration /incorporation under the governing legislation. The Consultant / Outsourcing agency/ Outsourcing Agency shall be required to submit a true copy of its Incorporation Certificate along with the Proposal (duly attested by a Notary Public).
- (ii) The applying firm should not have been sanctioned / blacklisted during the past 5 years (even if the sanction / blacklist was subsequently withdrawn) by any government / quasi government agency or any Multi-Lateral Donor Body (World Bank, ADB, JICA, KfW, etc.). Please attach a self-declaration stating the above.
- (iii) Experience in Project Implementation Unit /Project Management Unit / Project Management Consultancy / Construction Management and Supervision Consultancy in SwachhBharath Mission / Smart Cities Mission / AMRUT /under any State Government -Departments / under takings / Board / Authority (ies) and or / Government of India -Departments / under takings / Board / Authority (ies) in two completed projects in last 10 years with a minimum assignment value of Rs.20 lakhs in a single work order. Experience in any JV/Consortium will not be considered (duly attested by a Notary Public).
- (iv) The Consultant / Outsourcing agency/ Outsourcing Agency shall have average annual turnover of at least 2 (Two)Croresin last 3 (three) Financial Years. (2018-19, 2019-20& 2020-21). The Firm must ensure that they submit the evidence of eligibility criteria on turnover & positive net worth for above three financial years (2018-19, 2019-20& 2020-21) in the form of audited financial statements signed by Chartered Accountant for the last 3 (three) Financial Years. (2018-19, 2019-20& 2020-21). Audited financials shall be submitted as proof in the last three financial years as per the format attached Annexure 2 D.
- (v) Covers without **EMD** will be treated as non-responsive and will be disqualified.

It should be noted that "assignment along with client certificates only be considered for evaluation". Client certificates without attested by a Notary Public will be treated as non-responsive and will be disqualified.

Note: Covers without EMD will be treated as non-responsive and will be disqualified. (In the case exemption certificate for EMD available from MSME for consultancy sector, will be considered. Necessary validity proof shall be attached, *duly attested by a Notary Public*). Conditional Tender will be rejected summarily.

Curriculum vitae of the above Key personnel for assessing the qualifications and experience of the personnel proposed to be deployed should be included with the proposal (in the format of the sample curriculum vitae as prescribed in the Form F-3).

Key personal proficiency in Tamil language is essential it shall be exhibited in CV as per the Form 3.

Quality and competence of the consulting service shall be considered as one of the basic requirements. Technical proposals scoring not less than 75% of the total points will only be considered for financial evaluation.

The price envelopes of others will not be considered and returned unopened after completing the selection process. The client shall notify the Consultant / Outsourcing agencys, results of the technical evaluation and invite those who have secured the minimum qualifying mark for opening of the financial proposals indicating the date and time.

### 7.4 Financial Proposal (Cover 3)

### 7.4.1 Opening:

The financial proposal shall be opened in the presence of the firms' representatives who choose to attend. The name of the firm, the quality scores and the proposed prices shall be read out and recorded. The client shall prepare minutes of bid opening.

#### 7.4.2 Evaluation:

The evaluation committee will determine if the financial proposals are complete in accordance with ToR. The quoted price shall be corrected for arithmetical errors in accordance with Tender Transparency Rules 2000 and as amended there on.

### 8. Negotiations

- 8.1 Negotiations normally take a day. The aim is to reach agreement on all points and initial a draft contract by the conclusion of Negotiations.
- 8.2 Negotiations will commence with a discussion of your technical proposal, the proposed methodology (work plan), costing, staffing and any suggestions you may have made to improve the TORs. Agreement must then be reached on the final TORs, the staffing and staff months, logistics and reporting.
- 8.3 Changes agreed upon will then be reflected in the draft contract, using proposed unit rates (after negotiation of the unit rates, including the man month rates, tax liability and all cost, etc).
- 8.4 The negotiations will be concluded with a review of the draft form of Contract. The Client and the Firms will finalize the contract to conclude negotiations.

- 8.5 The Contract will be awarded after successful negotiations, with the selected Firm as per the Tamil Nadu Transparency in Tenders Act 1998 and Rules 2000 and as amended there on.
- 9. Fraud and Corrupt Practices
- 9.1 The Firm and its Personnel shall observe the highest standards of ethics and shall not have engaged in and shall not hereafter engage in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice (collectively the "Prohibited Practices"). Notwithstanding anything to the contrary contained in this Agreement, the Client shall be entitled to terminate this Agreement forthwith by a communication in writing to the Firm, without being liable in any manner whatsoever to the Firm, if it determines that the Firm has, directly or indirectly or through an agent, engaged in any Prohibited Practices in the Selection Process or before or after entering into of this Agreement. In such an event, the Client shall forfeit and appropriate the performance security, if any, as mutually agreed genuine pre-estimated compensation and damages payable to the Client towards, inter alia, the time, cost and effort of the Client, without prejudice to the Client's any other rights or remedy hereunder or in law.
- 10. Please note that the Client are not bound to select any of the firms submitting proposals. Further, as quality is the principal selection criterion, the CLIENT does not bind itself in any way to select the firm offering the lowest price.
- 11. The selected firm shall not disclose any information / data to others without the written permission of the CLIENT.
- 12. You are requested to hold your proposal valid for 90 days from the date of submission without changing the personnel proposed for the assignment and your proposed price. The CLIENT will make its best efforts to select a firm within this period.
- 13. Please note that the cost of preparing a proposal and of negotiating a contract including visits to CLIENT, if any is not reimbursable as a direct cost of the assignment.
- 14. Assuming that the contract can be satisfactorily concluded in May/June2022, you will be expected to take-up / commence with the assignment in May/June2022.
- 15. The successful bidder will be invited for signing agreement. The bidder is requested to furnish a performance security at the rate of 5% of the finalized agreement value in the form of Irrevocable Bank Guarantee from any one of the Nationalized / scheduled Bank in India taken in favour of the Mission Director, SBM (U), 2.0, DMA, Chennai valid for a period of 48 months or till the successful completion of the mission period and subject to extensions without any financial implications. The same will be released on successful completion of all the works satisfactorily. The validity of performance security will be extended according to the extension of contract period as per the agreement executed.
- 16. The Earnest Money Deposit of the successful Tenderer will be discharged when the Tenderer furnishes the required Performance Security and signs the Agreement.
- 17. The Earnest Money Deposit may be forfeited
  - (i) If the bidder withdraws the tender after Tender opening during the period of validity of the tender.
  - (ii) If the bidder withdraws the Tender after the issue of letter of acceptance of his Tender.
  - (iii) In the case of a successful bidder, if the bidder fails within the specified time limit to:
    - furnish the required performance security or
    - sign the Agreement
    - accept the Letter of Intent
  - (iv) if the bidder has furnished incorrect information on qualification and experience.
- 18. The fees shall be quoted in Indian Rupees only. Please note that the remuneration which you receive from the contract will be subject to normal tax liability in India. Kindly contact the concerned tax authorities for further information in this regard if required.

- 19. Any entity which has been barred by the Central Government, any State Government, a statutory Independent or a public sector undertaking, as the case may be, from participating in any project, and the bar subsists as on the date of Proposal, would not be eligible to submit a Proposal either by itself or through its Associate ("Associate" means a firm have common controlling shareholders or other ownership interest as that of the Bidder).
- 20. Please note that mobilization advance is not allowed in this contract.
- 21. It is estimated that about 48man-months for each key experts of services will be required for the study and generally you should base your financial proposal on this figure. Monthlypayments shall be paid as per the RFP terms and conditions to the successful Consultant / Outsourcing agencys shall be made by the Mission Director, SBM (U), 2.0, Chennai.
- 22. Joint Venture and Consortium / JV not allowed.
- 23. All documents relating to the Bid and all communications in connection with the Bid shall be in English language. All the pages should be serially numbered and signed by the Firms.
- 24. Any dispute arising out of the Contract, which cannot be amicably settled between the parties, shall be referred to adjudication/arbitration in accordance with the Arbitration & Conciliation Act 1996. The place of arbitration shall be at Chennai. The jurisdiction of court will be at Chennai. (Chennai city civil courts)
- 25. DMA/ MD SBM (U) TNreserves the right to postpone / cancel this RFP at any point of time without assigning any reason, whatsoever.
- 26. Please note that conditional bids *are liable for rejection*.
- 27. The key experts proposed shall be full time for this assignment only.
- 28. Removal and / or Replacement of Personnel:
  - a) Expect as the Client may otherwise agree, no changes shall be made in the Personnel. If, for any reason beyond the reasonable control of the Consultant / Outsourcing agency, such as retirement, death, medical incapacity, among others, it becomes necessary to replace any of the Personnel, the Consultant / Outsourcing agency shall forthwith provide as a replacement a person of equivalent or better qualifications and experience.
  - b) If the Client (i) finds that any of the Personnel has committed serious misconduct or has been charged with having committed a criminal action, to (ii) has reasonable cause to be dissatisfied with the performance of any of the Personnel, then the Consultant / Outsourcing agency shall, at the Client written request specifying the grounds therefore, for with provide as a replacement a person with qualifications and experience acceptable to the Client".
  - c) Any of the Personnel provided as a replacement under Clauses a) and b) above, the rate of remuneration applicable to a replacement person will be same as per the agreement. Also (i) the Consultant / Outsourcing agency shall bear all additional travel and other costs arising out of or incidental to any removal and / or replacement, and (ii) the remuneration to be paid for any of the Personnel provided as a replacement shall not exceed the remuneration which would have been to the Personnel replaced.

## 29. SETTLEMENT OF DISPUTES

- 29.1 Amicable Settlement The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Contract or the interpretation thereof.
- 29.2 Miscellaneous. In any arbitration proceeding hereunder:
- (a) proceedings shall, unless otherwise agreed by the Parties, be held in Chennai.
- (b) the English language shall be the official language for all purposes; and

- (c) the decision of the sole arbitrator or of a majority of the arbitrators (or of the third arbitrator if there is no such majority) shall be final and binding and shall be enforceable in a court of competent jurisdiction (Chennai), and the Parties hereby waive any objections to or claims of immunity in respect of such enforcement.
- 30. This Contract may be terminated by either Party as per provisions set up below:

### a. By the Client

The Client may terminate this Contract in case of the occurrence of any of the events specified in paragraphs (a) through (f) of this Clause. In such an occurrence the Client shall give at least thirty (30) calendar days' written notice of termination to the Consultant / Outsourcing agency in case of the events referred to in (a) through (d); at least sixty (60) calendar days' written notice in case of the event referred to in (e); and at least five (5) calendar days' written notice in case of the event referred to in (f):

- (a) If the Consultant / Outsourcing agency fails to remedy a failure in the performance of its obligations hereunder, as specified in a notice of suspension;
- (b) If the Consultant / Outsourcing agency becomes (or, if the Consultant / Outsourcing agency consists of more than one entity, if any of its members becomes) insolvent or bankrupt or enter into any agreements with their creditors for relief of debt or take advantage of any law for the benefit of debtors or go into liquidation or receivership whether compulsory or voluntary;
- (c) If the Consultant / Outsourcing agency fails to comply with any final decision reached as a result of arbitration proceedings;
- (d) If, as the result of Force Majeure, the Consultant / Outsourcing agency is unable to perform a material portion of the Services for a period of not less than sixty (60) calendar days;
- (e) If the Client, in its sole discretion and for any reason whatsoever, decides to terminate this Contract;
- (f) If the Consultant / Outsourcing agency fails to confirm availability of Key Experts as required as per ToR. Furthermore, if the Client determines that the Consultant / Outsourcing agency has engaged in Fraud and Corruption in competing for or in executing the Contract, then the Client may, after giving fourteen (14) calendar days written notice to the Consultant / Outsourcing agency, terminate the Consultant / Outsourcing agency's employment under the Contract.

### b. By the Consultant / Outsourcing agency

The Consultant / Outsourcing agency may terminate this Contract, by not less than thirty (30) calendar days' written notice to the Client, in case of the occurrence of any of the events specified in paragraphs (a) through (d) of this Clause.

- (a) If the Client fails to pay any money due to the Consultant / Outsourcing agency pursuant to this Contract and not subject to dispute within forty-five (45) calendar days after receiving written notice from the Consultant / Outsourcing agency that such payment is overdue.
- (b)If, as the result of Force Majeure, the Consultant / Outsourcing agency is unable to perform a material portion of the Services for a period of not less than sixty (60) calendar days.
- (c) If the Client fails to comply with any final decision reached as a result of arbitration.
- (d)If the Client is in material breach of its obligations pursuant to this Contract and has not remedied the same within forty-five (45) days (or such longer period as the Consultant / Outsourcing agency may have subsequently approved in writing) following the receipt by the Client of the Consultant / Outsourcing agency's notice specifying such breach.

### c. Cessation of Services:

Upon termination of this Contract by notice of either Party to the other, the Consultant / Outsourcing agency shall, immediately upon dispatch or receipt of such notice, take all necessary steps to bring the Services to a close in a prompt and orderly manner and shall make every reasonable effort to keep expenditures for this purpose to a minimum. Upon termination of this Contract, the Client shall make the payments to the Consultant / Outsourcing agency: for Services satisfactorily performed prior to the effective date of termination

#### a. Definition

For the purposes of this Contract, "Force Majeure" means an event which is beyond the reasonable control of a Party, is not foreseeable, is unavoidable, and makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible under the circumstances, and subject to those requirements, includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial action confiscation or any other action by Government agencies.

Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or such Party's Experts, Sub-Consultant or agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected to both take into account at the time of the conclusion of this Contract, and avoid or overcome in the carrying out of its obligations hereunder.

Force Majeure shall not include insufficiency of funds or failure to make any payment required hereunder.

### b.No Breach of Contract

The failure of a Party to fulfill any of its obligations hereunder shall not be considered to be a breach of, or default under, this Contract insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Contract.

#### c.Measures to be Taken

A Party affected by an event of Force Majeure shall continue to perform its obligations under the Contract as far as is reasonably practical and shall take all reasonable measures to minimize the consequences of any event of Force Majeure.

A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible, and in any case not later than fourteen (14) calendar days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give written notice of the restoration of normal conditions as soon as possible.

Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

During the period of their inability to perform the Services as a result of an event of Force Majeure, the Consultant / Outsourcing agency, upon instructions by the Client, shall either:

- (a) demobilize, in which case the Consultant / Outsourcing agency shall be reimbursed for additional costs they reasonably and necessarily incurred, and, if required by the Client, in reactivating the Services; or
- (b) continue with the Services to the extent reasonably possible, in which case the Consultant / Outsourcing agency shall continue to be paid under the terms of this Contract and be reimbursed for additional costs reasonably and necessarily incurred. In the case of disagreement between the Parties as to the existence or extent of Force Majeure, the matter shall be settled according to Clause 29.

### Suspension

The Client may, by written notice of suspension to the Consultant / Outsourcing agency, suspend part or all payments to the Consultant / Outsourcing agency hereunder if the Consultant / Outsourcing agency fails to perform any of its obligations under this Contract, including the carrying out of the Services, provided that such notice of suspension (i) shall specify the nature of the failure, and (ii) shall request the Consultant / Outsourcing agency to remedy such failure within a period not exceeding thirty (30) calendar days after receipt by the Consultant / Outsourcing agency of such notice of

Terms of Reference for "Establishment of Programme Implementation Units(PIU) at Regional Directorate of Municipal Administration, Chengalpattu Region, Tambaramto provide handholding support to Mission Director for implementation of Swachh Bharat Mission – Urban 2.0 (SBM (U) 2.0), Tamil Nadu".

# 1. Background

# b.No Breach of Contract

The failure of a Party to fulfill any of its obligations hereunder shall not be considered to be a breach of, or default under, this Contract insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Contract.

### c.Measures to be Taken

A Party affected by an event of Force Majeure shall continue to perform its obligations under the Contract as far as is reasonably practical and shall take all reasonable measures to minimize the consequences of any event of Force Majeure.

A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible, and in any case not later than fourteen (14) calendar days following the occurrence of such event, providing evidence of the nature and cause of such event,

and shall similarly give written notice of the restoration of normal conditions as soon as possible.

Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

During the period of their inability to perform the Services as a result of an event of Force Majeure, the Consultant / Outsourcing agency, upon instructions by the Client, shall either:

- (a) demobilize, in which case the Consultant / Outsourcing agency shall be reimbursed for additional costs they reasonably and necessarily incurred, and, if required by the Client, in reactivating the Services; or
- (b) continue with the Services to the extent reasonably possible, in which case the Consultant / Outsourcing agency shall continue to be paid under the terms of this Contract and be reimbursed for additional costs reasonably and necessarily incurred. In the case of disagreement between the Parties as to the existence or extent of Force Majeure, the matter shall be settled according to Clause 18.

Suspension

The Client may, by written notice of suspension to the Consultant / Outsourcing agency, suspend part or all payments to the Consultant / Outsourcing agency hereunder if the Consultant / Outsourcing agency fails to perform any of its obligations under this Contract, including the carrying out of the Services, provided that such notice of suspension (i) shall specify the nature of the failure, and (ii) shall request the Consultant / Outsourcing agency to remedy such failure within a period not exceeding thirty (30) calendar days after receipt by the Consultant / Outsourcing agency of such notice of suspension.

- 23. Any dispute arising out of the Contract, which cannot be amicably settled between the parties, shall be referred to Adjudication / arbitration in accordance with the Arbitration & Conciliation Act 1996. The place of arbitration shall be at Chennai.
- 24. The jurisdiction of court will be at Chennai.
- 25. Conflict of Interests: The Consultant / Outsourcing agency shall hold the Client's interests paramount, without any consideration for future work, and strictly avoid conflict with other assignments or their own corporate interests. Consultant / Outsourcing agency Not to Benefit from Commissions, Discounts, etc.: The payment of the Consultant / Outsourcing agency shall constitute the Consultant / Outsourcing agency's only payment in connection with this Agreement, the Consultant / Outsourcing agency shall not accept for its own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Agreement or in the discharge of its obligations hereunder, and the Consultant / Outsourcing agency shall use its best efforts to ensure that the Experts and agents of them, similarly shall not receive any such additional payment.
- 25.1. Furthermore, if the Consultant / Outsourcing agency, as part of the Services, has the responsibility of advising the Client on the procurement of goods, works or services, the Consultant / Outsourcing agency shall comply with the TT Act, and shall at all times exercise such responsibility in the best interest of the Client.
- 25.2. Consultant / Outsourcing agency and Affiliates Not to Engage in Certain Activities: The Consultant / Outsourcing agency agrees that, during the term of this Agreement and after its termination, the Consultant / Outsourcing agency and any entity affiliated with the Consultant / Outsourcing agency and any entity affiliated, shall be disqualified from providing goods, works or non-consulting services resulting from or directly related to the Consultant / Outsourcing agency's Services for the preparation or implementation of the project.
- 25.3. Prohibition of Conflicting Activities: The Consultant / Outsourcing agency shall not engage, and shall cause its Experts not to engage, either directly or indirectly, in any business or professional activities that would conflict with the activities assigned to them under this Agreement.

- 25.4. Strict Duty to Disclose Conflicting Activities: The Consultant / Outsourcing agency has an obligation and shall ensure that its Experts shall have an obligation to disclose any situation of actual or potential conflict that impacts their capacity to serve the best interest of their Client, or that may reasonably be perceived as having this effect. Failure to disclose said situations may lead to the disqualification of the Consultant / Outsourcing agency or the termination of its Agreement.
- 26. Confidentiality: Except with the prior written consent of the Client, the Consultant / Outsourcing agency and the Experts shall not at any time communicate to any person or entity any confidential information acquired in the course of the Services, nor shall the Consultant / Outsourcing agency and the Experts make public the recommendations formulated in the course of, or as a result of, the Services.
- 27. Accounting, Inspection and Auditing: The Consultant / Outsourcing agency shall keep, accurate and systematic accounts and records in respect of the Services and in such form and detail as will clearly identify relevant time changes and costs. The Consultant / Outsourcing agency shall permit, the Client / GoTN and/or persons appointed by the Client / GoTN to inspect the Site and/or all accounts and records relating to the performance of the Agreement and the submission of the Proposal to provide the Services, and to have such accounts and records audited by auditors appointed by the Client / GoTN if requested by the Client / GoTN.
- 28. The assignment may be deferred or foreclosed / terminated at any stage either in full or in part due to unavoidable circumstances / administrative reasons.
