**ORDER:**

Based on the recommendations of the Sixth State Finance Commission, vide the Government Order first read above, and Government in the G.O. 2<sup>nd</sup> read above have accorded sanction for the release of **Rs.1197,63,71,429/-** (Rupees One thousand one hundred ninety seven crore sixty three lakh seventy one thousand four hundred and twenty nine only) as Devolution of 6<sup>th</sup> SFC to the **CORPORATIONS** for the months of **April 2023 to January 2024**.

In the reference G.O.3<sup>rd</sup> read above have accorded sanction for the release of **Rs. 388,73,56,571/-** (Rupees Three hundred eighty eight crore seventy three lakh fifty six thousand five hundred and seventy one only) as Devolution of 6<sup>th</sup> SFC to the Municipalities for the months February & March 2024.
